FILING DEADLINE

Friday, January 17, 2025 AT 7:00 P.M.

The Prince George's County Democratic Central Committee (PGCDCC) will convene a virtual public hearing on Tuesday, January 21, 2025, at 7 pm to fill District 23 Central Committee vacancy.

PGDCC Member Dr. Darren Gibson has resigned.

The PGCDCC will only receive male candidates who reside in District 23 due to gender balancing.

ELIGIBILITY REQUIREMENTS AND INSTRUCTIONS FOR FILING:

- Candidates must be a registered voter in Prince George's County, Maryland and reside in the legislative district where the vacancy has occurred.
- The PGCDCC requires the following documents in PDF format: (1) letter of intent;
 (2) resume; and (3) voter registration card.
- Filing deadline: 7pm, Friday, January 17, 2025. Email all required documents in PDF format only to: pgcdccinfo@gmail.com
- Incomplete packets and packets received after the deadline will not be accepted.
- Candidates shall speak in alphabetical order, 2-minutes per candidate.
- Candidates may have no more than 2 people speak on their behalf, 2-minutes each.
- Speakers may not transfer their time to another speaker.
